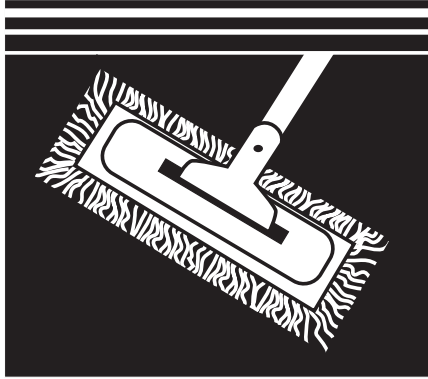

Ideal for maintaining all types of flooring, including wood, vinyl, terrazzo, concrete synthetic sports floors and sealed or painted surfaces. Daily dust mopping with this product will increase the life and beauty of floors by reducing the abrasive effects of tracked in dirt. Ideal for removing black rubber heel marks.

### Directions For Use

For a new mop or a mop that has been cleaned thoroughly, use 2 ounces of product per linear foot of dust mop. Sprinkle or coarse spray on mop strands. Hang treated mop in well-ventilated area until next day's use. Dirt and dust can easily be removed from treated mop by vigorously shaking. For daily care, shake out dust and spread wicks apart. Retreat with 1 ounce of product per linear foot. When mop becomes too soiled, launder and re-treat.

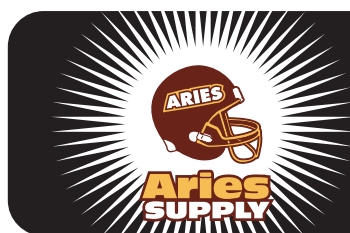

## SECTION 6-STORAGE AND HANDLING INFORMATION

Use only with adequate ventilation. Avoid breathing of vapors or mists. Keep out of reach of children. For use by trained personnel only. Keep container closed during storage. For institutional and industrial use only. Avoid contact with eyes, skin and clothing. Wash thoroughly with soap and water after handling.

## SECTION 7-HEALTH HAZARDS AND FIRST AID

**Effects of Overexposure:**  
**Skin:** Prolonged or repeated contact may cause irritation or dermatitis.  
**Eyes:** Eye irritant. May cause redness, swelling, or blurred vision.  
**Inhalation:** May cause dizziness or drowsiness.  
**Ingestion:** May cause dizziness, drowsiness or narcosis. Aspiration of material into the lungs can cause pneumonitis.

**First Aid Procedures:**

**Skin:** Remove contaminated clothing. Wash with soap and water. Seek medical attention if irritation persists.  
**Eyes:** Flush with large quantities of water, holding eyelids open. Seek medical attention.  
**Inhalation:** Get to fresh air. If breathing is difficult, give oxygen. Seek medical attention if symptoms persist.  
**Ingestion:** Do not induce vomiting. Seek medical attention immediately.

## SECTION 8-SPECIAL PROTECTION INFORMATION

**Respiratory Protection:** Use with adequate ventilation. Use NIOSH/MSHA approved hydrocarbon canister or respirator when using in poorly ventilated areas.  
**Ventilation Requirements:** Provide mechanical exhaust to keep TLV of Section 2 ingredients below acceptable limit.  
**Protective Gloves:** Solvent proof rubber or neoprene.  
**Eye Protection:** Chemical splash goggles.  
**Other Protective Equipment:** Eyewash and fire extinguisher should be located nearby when using.

## SECTION 9-SPILL OR LEAK PROCEDURES

**Steps to be taken in Case Material is Released or Spilled:** Floors will become slippery. Avoid walking in product. Keep unessential personnel away. Mop up or otherwise absorb and hold disposal. Avoid discharge to sewer or open waterways.  
**Waste Disposal Method:** Any method in accordance with local, state and federal laws. Best method is to recycle or reuse for intended purpose. Consult local authorities for disposal in public sewer. Do not dispose of into storm drain, stream, river or to ground. Rinse container thoroughly before discarding in trash.
